1. ADMISSION REQUIREMENTS

To be admitted to the Graduate Programme in Banking and Finance, it is necessary to meet the admission requirements set out in the following paragraphs.

1.1. Curricular requirements

To access the Graduate Programme in Banking and Finance, it is necessary to meet either the requirements under A or the requirements under B:

- A. An undergraduate degree belonging to the L-18 Economics and Management Sciences degree class (ex-Ministerial Decree 270/04 or class 17 ex M.D. 509/99) obtained or to be obtained by 31 December 2024 and a defined number of ECTS in the syllabus of the undergraduate degree or of the first level university master's degree ,or as single courses passed, in the following scientific-disciplinary sectors:
 - **20 ECTS** in the first economic sector: SECS-P/07, SECS-P/08, SECS-P/10;
 - **20 ECTS** in the second economic sector: SECS-P/09, SECS-P/11;
 - **20 ECTS** in the third economic sector: SECS-P/01, SECS-P/02, SECS-P/03, SECS-P/04, SECS-P/05, SECS-P/06, SECS-P/12;
 - **20 ECTS** in the mathematical and statistics sectors: MAT/05, MAT/06, MAT/08, MAT/09, SECS-S/01, SECS-S/02, SECS-S/03, SECS-S/04, SECS-S/05, SECS-S/06;
 - **16 ECTS** in the legal sector: IUS/01, IUS/04, IUS/05, IUS/07, IUS/09, IUS/12, IUS/14, IUS/17.

Up to 20 ECTS may be missing from the required ECTS, of which a maximum of 15 ECTS in the sectors SECS-P/09 and SECS-P/11.

The programme coordinator reserves the right to assess whether the required teaching content has been included in the undergraduate programme syllabus and, if necessary, to draw up an *ad hoc* degree curriculum. Candidates will receive appropriate communication.

- B. An undergraduate degree (ex M.D. 270/04 ex M.D. 509/99) obtained or to be obtained by 31 December 2024 and a defined number of ECTS in the syllabus of the undergraduate degree or of the first level university master's degree, or as single courses passed, in the following scientificdisciplinary sectors:
 - 20 ECTS in the first economic sector: SECS-P/07, SECS-P/08, SECS-P/10;
 - 20 ECTS in the second economic sector: SECS-P/09, SECS-P/11;
 - **20 ECTS** in the third economic sector: SECS-P/01, SECS-P/02, SECS-P/03, SECS-P/04, SECS-P/05, SECS-P/06, SECS-P/12;
 - **20 ECTS** in the mathematical and statistics sectors: MAT/05, MAT/06, MAT/08, MAT/09, SECS-S/01, SECS-S/02, SECS-S/03, SECS-S/04, SECS-S/05, SECS-S/06;
 - 16 ECTS in the legal sector: IUS/01, IUS/04, IUS/05, IUS/07, IUS/09, IUS/12, IUS/14, IUS/17.

Up to 20 ECTS may be missing from the required ECTS, of which a maximum of 15 ECTS the sectors SECS-P/09 and SECS-P/11.

The programme coordinator reserves the right to assess whether the required teaching content has been included in the undergraduate programme syllabus and, if necessary, to draw up an *ad hoc* degree curriculum. Candidates will receive appropriate communication.

The syllabus of candidates with an old university degree or an undergraduate university diploma or a diploma from a school for special purposes in accordance with the pre-Ministerial Decree. 509/99 or integrated/graduate from post-Ministerial Decree regulations 509/99-M.D. 270/04 is assessed by a special Commission appointed by the Faculty.



1.2. English language knowledge

In addition to the admission requirements above, it is mandatory to have an adequate knowledge of English, corresponding to at least a B2 level. It is therefore necessary to have **one of the following English language certifications obtained as of 1 January 2022**:

- TOEFL/IBT (score of at least 84);
- Academic IELTS (score of at least 6 for the Early Phase and of at least 6.5 for the other Phases);
- Cambridge English: First FCE (score of at least 173);
- Cambridge English: Advanced CAE;
- Cambridge English: Proficiency CPE;
- Cambridge English: Business English Certificate (BEC Vantage and BEC Higher);
- Trinity College London: ISE II (B2);
- Trinity College London: ISE III (C1);
- Trinity College London: ISE IV (C2);
- Pearson: PTE with score from 46;

or one of the following requirements:

- an undergraduate degree or equivalent obtained in English;
- a double undergraduate degree taught in English, awarded or to be awarded;
- the candidate comes from one of the profiles/programmes taught in English at Università Cattolica del Sacro Cuore.

In case the indicated certifications or requirements are missing, it is necessary to take an *English Test*, (at least level B2) within the deadline for submitting the application form (see section 3 ADMISSION PROCEDURES AND DEADLINES), organised by Se.L.D'A, the Language Service of Università Cattolica del Sacro Cuore. The enrolment procedures are indicated in the appropriate <u>section</u>.

2. NUMBER OF PLACES AVAILABLE

There are **100 places** on the Graduate Programme in Banking and Finance, **25 of which are reserved for candidates with foreign qualifications**.

3. ADMISSION PROCEDURES AND DEADLINES

Places on in Banking and Finance Graduate Programme are allocated according to 3 admission phases.

Candidates with an Italian study qualification must use the <u>Enrolment Portal</u>; for information on the procedure to follow, please consult the <u>Enrolment Portal User Guide</u>.

Candidates with a foreign qualification or with an ecclesiastical title must comply with the provisions issued by the Ministry of University and Research, which have been published in a specific note. 3.1. Early phase - Merit ranking

For candidates on the undergraduate degree programme in Economics of Markets and Financial Intermediaries at Università Cattolica del Sacro Cuore with a weighted average of \geq 24/30 and with at least 120 ECTS acquired

APPLICATION SUBMISSION: from 09 January 2024 to 05 February 2024–35 places

Without prejudice to the possession of the ADMISSION REQUIREMENTS, only candidates from the undergraduate degree programme in Economics of Markets and Financial Intermediaries at Università Cattolica del Sacro Cuore with a weighted average of the examinations taken higher than or equal to 24/30 and with at least 120 ECTS acquired, who are directly recognised as having an adequate personal preparation, may apply for admission to the merit ranking.

Applications must be submitted via the <u>Enrolment Portal</u> from 10:00 on 09 January 2024 until 23:59 on 05 February 2024.

By **09 February 2024, the merit ranking of admitted candidates will be published** on the basis of the weighted average of the marks obtained in the examinations taken (see section 4 RANKING)

Admitted candidates, by 23:59 on **14 February 2024, must reserve** their place by paying the first instalment of university tuition fees through the <u>Enrolment Portal</u>.

Candidates who do not reserve their place by the dates indicated, if interested in participating in the next phase, must submit a new application, requesting the cancellation of the one previously opened. This request must be made at least two working days before the deadline of the phase of interest via the following link: <u>https://www.unicatt.it/richiesta-informazioni-lauree-magistrali</u>.

3.2. Ordinary phase – Merit ranking

For all candidates with a weighted average of \geq 24/30 and at least 120 ECTS acquired

APPLICATION SUBMISSION: from 19 February 2024 to 18 March 2024 – For places remaining from the previous phase

A notice stating the number of places that may be available for the Ordinary phase will be published on the website on 16 February 2024.

Provided that all ADMISSION REQUIREMENTS are met, candidates from the undergraduate degree programme in Economics of Markets and Financial Intermediaries at Università Cattolica del Sacro Cuore with a **weighted average higher than or equal to 24/30 and with at least 120 ECTS acquired**, are directly recognised as having satisfactory personal preparation and may apply for admission to the ranking list for places available at the end of the Early phase.



Applications must be submitted via the <u>Enrolment Portal</u> from 10:00 on 19 February 2024 until 23:59 on 18 March 2024.

Without prejudice to compliance with the ADMISSION REQUIREMENTS, candidates with a **weighted average** higher than or equal to 24/30 and with at least 120 ECTS acquired:

- coming from another university;
- coming from other undergraduate programmes at Università Cattolica del Sacro Cuore;
- the adequacy of personal preparation is not directly recognised.

Candidates can submit their application to the ranking through the <u>Enrolment Portal</u> from 10:00 on 19 February 2024 until 23:59 on 18 March 2024.

Acceptance of the application is subject to the degree programme coordinator's assessment of the knowledge and skills required through a careful analysis of the curriculum or even through an interview with the candidates. In this case, an e-mail will be sent to the candidates with the result of the evaluation. Only in case of a negative result, candidates **cannot participate in the ranking** and may request an interview with the programme coordinator in order to discuss the reasons for their exclusion (see section 5 EVALUATION OF THE SYLLABUS).

By 25 March 2024, the merit ranking of admitted candidates will be published on the basis of the weighted average of the marks obtained in the examinations taken (see section 4 RANKING).

Admitted candidates, by **23:59 on 02 April 2024, must reserve** their place by paying the first instalment of university tuition fees through the <u>Enrolment Portal</u>.

To find out how to apply for admission and reserve a place, please consult the <u>Enrolment Portal User</u> <u>Guide</u>.

Candidates who do not reserve their place by the dates indicated, if interested in participating in the next phase, must submit a new application, requesting the cancellation of the one previously opened. 3.3. Residual phase – Merit ranking

For all candidates with a weighted average of \geq 23/30 and at least 135 ECTS acquired

APPLICATION SUBMISSION: from 06 May 2024 to 24 June 2024 – For places remaining from the previous phase

A notice stating the number of places that may be available for the Residual phase will be available on the website on 29 April 2024.

Provided that all ADMISSION REQUIREMENTS are met, candidates from the undergraduate degree programme in Economics of Markets and Financial Intermediaries at Università Cattolica del Sacro Cuore with a **weighted average higher than or equal to 23/30 and with at least 135 ECTS** acquired, are directly recognised as having satisfactory personal preparation and may apply for admission to the ranking for places available at the end of the Ordinary phase.

Applications must be submitted via the <u>Enrolment Portal</u> from 10:00 on 06 May 2024 until 23:59 on 24 June 2024.

Without prejudice to compliance with the ADMISSION REQUIREMENTS, candidates with a **weighted average** higher than or equal to 23/30 and with at least 135 ECTS acquired:

- coming from another university;
- coming from other undergraduate programmes at Università Cattolica del Sacro Cuore;
- the adequacy of personal preparation is not directly recognised.



Candidates can **submit their application to the ranking** through the <u>Enrolment Portal</u> from 10:00 on 06 May 2024 until 23:59 on 24 June 2024.

Acceptance of the application is subject to the degree programme coordinator's assessment of the knowledge and skills required through a careful analysis of the curriculum or even through an interview with the candidates. In this case, an e-mail will be sent to the candidates with the result of the evaluation. Only in case of a negative result, candidates **cannot participate in the ranking** and may request an interview with the programme coordinator in order to discuss the reasons for their exclusion (see section 5 EVALUATION OF THE SYLLABUS).

By **01 July 2024, the ranking of admitted candidates will be published** on the basis of the weighted average of the marks obtained in the examinations taken (see section 4 RANKING).

Admitted candidates, by **23:59 on 04 July 2024, must reserve** their place by paying the first instalment of university tuition fees through the <u>Enrolment Portal</u>.

If there are still vacant places at the end of the ranking process, a further admission phase will be organised.

4. RANKING

Candidates participate in a merit ranking by submitting their application via the <u>Enrolment Portal</u> and may submit up to two applications per phase, indicating for each one the order of preference (e.g. Option 1 is equivalent to the first-choice programme/profile and Option 2 is equivalent to the second-choice programme/profile) and choosing from the following programmes/profiles:

- Banking and Finance;
- Economics of Markets and Financial Intermediaries Finance profile,
- Economics of Markets and Financial Intermediaries Finance Corporate advisory (in agreement) profile;
- Economics of Markets and Financial Intermediaries Banking and Insurance Management profile

For the Banking and Finance programme, a ranking is drawn up containing applications for the first option, in order of merit, followed by those for the second option, also in order of merit.

The ranking is drawn on the basis of the weighted average of the marks obtained in the examinations taken during the undergraduate degree programme when the requirements are checked. In the event of a tie, priority is given to the youngest candidate.

From the dates indicated in section 3 ADMISSION PROCEDURES AND DEADLINES, candidates can find on the website <u>www.unicatt.it</u>, under the heading "Rankings and waiting lists" on the page for the degree programme in <u>Banking and Finance</u>, the ranking of admitted candidates and any waiting lists. To find out how to reserve a place, please consult the <u>Enrolment Portal User Guide</u>.

Candidates admitted to the programme indicated as the **first option** will automatically **have their applications for the programme indicated as the second option**, **if expressed, cancelled**. Candidates admitted to the programme indicated as the **second option** remain on the waiting list for the programme indicated as the first option. These candidates therefore compete for admission to the first option programme, against any places still available, even if they have reserved a place on the second option programme.

Once a place has been reserved for the Banking and Finance programme, it is not possible to participate in the next phase for any of the programmes/profiles listed above.



The publication of the rankings is an official communication to the candidates concerned. Admitted candidates who do not respect the deadlines indicated are considered to have withdrawn in favour of candidates on the waiting list.

5. EVALUATION OF THE SYLLABUS

The evaluation of the syllabus is carried out remotely and is aimed at verifying that the undergraduate programme syllabus contains the required teaching content.

Following this assessment, candidates are notified by e-mail of the outcome.

6. ENROLMENT AND PRE-ENROLMENT

Graduate candidates must reserve their place, paying the first instalment of university fees and contributions, by the deadlines indicated in Section 3 ADMISSION PROCEDURES AND DEADLINES and proceed to **enrolment** through the <u>Enrolment Portal</u>.

For those who have reserved their place by **12 August 2024**, the deadline for registration is **12 September 2024**. If a place is reserved after **12 August 2024**, the deadline for registration is **30 days from the date the place is reserved** and **no later than 31 December 2024**.

Candidates should consult the Enrolment Portal User Guide to find out about the enrolment procedure.

Candidates about to graduate must reserve their place, paying the first instalment of fees and university contributions through the <u>Enrolment Portal</u>, by the deadlines indicated in paragraph 3 ADMISSION PROCEDURES AND DEADLINES and immediately proceed with pre-enrolment through the <u>Enrolment Portal</u>.

Pre-enrolment for the Graduate Programme is accepted with reservation and is subject to obtaining the qualification within the deadlines laid down in the admission procedures.

Pre-enrolled candidates reserve their place with the right to attend the Graduate Programme from the start. They are required to complete their enrolment immediately after obtaining their degree and in any case no later than 31 December 2024.

To find out about the pre-enrolment and enrolment procedure, candidates should consult the <u>Enrolment</u> <u>Portal User Guide.</u>

For those enrolled who have taken the English test, the participation fee paid to take the test will be deducted from the total amount of university contributions for the 2024/2025 academic year.

7. CANDIDATES WITH DISABILITIES OR WITH SPECIFIC LEARNING DISORDERS (SLD)

Candidates with disabilities or Specific Learning Disorders (SLD) are required to upload their disability report or certificate of SLD in the appropriate section of their profile in the Enrolment Portal. For further information please contact the secretariat of the <u>Services for Inclusion</u>.

Students admitted to the course with a certified disability equal to or greater than 66% and/or students with a recognised disability pursuant to art. 3, paragraph 1 or paragraph 3, of Law 104/1992, are entitled to total exemption from tuition fees and university contributions and are required to pay €100 when reserving a place on the course. To obtain the exemption, the disability report must be uploaded in the "Profile" section of the Enrolment Portal.

8. TRANSFER FROM ANOTHER UNIVERSITY, SECOND DEGREE AND RESUMPTION OF CAREER

Candidates wishing to transfer from another university, enrol in a second degree or resume their university career must meet the ADMISSION REQUIREMENTS and comply with the deadlines and procedures set out in section 3 ADMISSION PROCEDURES AND DEADLINES.



Depending on the admission phase to which they belong, candidates must submit their application for admission to the Graduate degree Programme in **Banking and Finance** through the <u>Enrolment Portal</u>. Following admission, it is necessary to reserve the place, pay the first instalment and the secretarial fees, and submit the application through the <u>Enrolment Portal</u> within the deadlines indicated in section 3 ADMISSION PROCEDURES AND DEADLINES.

Candidates who transfer from another university, after having reserved their place, may sit other examinations, at their university of origin, until they submit their **Transfer Application**, which must normally be submitted no later than **31 October 2024**. The place is reserved when the documentation submitted is validated by the Student Services Centre.

The competent teaching structure will only assess examinations taken and recorded up to the submission of the Transfer Application.

Candidates enrolling for a second degree, after reserving their place by paying the first instalment and the secretarial fees, must submit an **Application for a Second Degree**, which must normally be submitted no later than **31 December 2024.** The degree from the home programme must necessarily be obtained by 31 December 2024. The place is reserved when the submitted documentation is validated by the Student Services Centre.

Candidates resuming their career, after having paid the first instalment and the secretarial fees, must submit an **Application for Resumption of Career**, which must normally be submitted no later than **31 October 2024**. The place is reserved when the documentation submitted is validated by the Student Services Centre.

Candidates are required to forward a copy of the course programmes and examinations passed at their home university, in PDF format, to the following e-mail address <u>domanda.istruttoria-mi@unicatt.it</u>. The syllabus must contain information regarding the details of the topics, bibliography and reference professors/lecturers.

At least 40 validated ECTS are required for admission to the 2nd year.

Only examinations taken in English are validated.

9. PROGRAMME CHANGE WITHIN UNIVERSITÀ CATTOLICA

Candidates wishing to transfer to a programme/profile within Università Cattolica must meet the ADMISSION REQUIREMENTS and comply with the deadlines and procedures indicated in section 3 ADMISSION PROCEDURES AND DEADLINES.

Depending on the admission phase to which they belong, candidates must submit their application for admission to the Graduate degree Programme in **Banking and Finance** through the <u>Enrolment Portal</u>. Following admission, it is necessary to reserve the place, pay the first instalment and secretarial fees, and submit the application through the <u>Enrolment Portal</u> within the deadlines indicated in section 3 ADMISSION PROCEDURES AND DEADLINES.

After reserving a place, it is possible to take other examinations of the programme/profile of origin until the start of the Change procedure, which is done by clicking the "**Proceed with Change**" function in the Enrolment Portal, normally no later than **31 October 2024.**

The competent teaching structure will only assess the examinations taken and recorded until the start of the Change procedure.

At least 40 validated ECTS are required for admission to the 2nd year.

Only examinations taken in English are validated.
